## **Boulder Fire Rescue CITIZENS' ACADEMY**

### **AGREEMENT TO PARTICIPATE ASSUMPTION OF RISK RELEASE AND INDEMNIFICATION**

To enable Boulder Fire Rescue ("BFR") to educate citizens on the nature and scope of fire functions and activities, and thereby increase citizens understanding and awareness of the numerous challenges faced by a fire department, the BFR has developed the BFR Citizens' Academy. Chosen participants of the BFR Citizens' Academy are taught fire tactics and procedures and participate in simulated fire actions which give such citizen a unique opportunity to more fully appreciate fire work.

Now, therefore, in consideration of the benefits that I will receive from my decision to volunteer as a participant in the Boulder Fire Rescue Citizens' Academy sponsored by the Boulder Fire Department, I \_\_\_\_\_ do hereby agree as follows:

1. I understand that participation in the BFR Citizens' Academy is voluntary and I hereby represent, by my signature below, that my decision to participate was made voluntarily with full knowledge of the consequences as set forth herein.
2. I acknowledge and understand that participation in the BFR Citizens' Academy necessarily involves an inherent risk of physical injury through my active participation in various physical activities including fire tactics and my use of fire tools, such as, but not limited to, various types of power tools, ladders, extrication equipment, high pressure hose streams, and turn-out gear. Simulated fire actions involve use of a fire extinguisher to extinguish burning flammable liquid and wood props. Such physical injury may be severe and may include disfigurement, disability, broken bones or death. I understand that participation also involves the risk of loss or damage to any personal property or belongings I have with me during such participation.
3. I also understand that I may voluntarily choose to participate in ladder work at elevated heights and other more strenuous sessions involving physical activity in connection with technical rescue training, collapse and limited visibility searches, and performing extrication from simulated auto accidents which also involves inherent risk of injury. I understand that participation in these sessions poses additional inherent risks of serious physical injury, disability, disfigurement or death. Further, I recognize and acknowledge any instructional session is not intended to be nor should it be relied upon to be a substitute for any type of accredited, qualifying or certified class as it relates to such instruction. All instruction at the BFR Citizens' Academy is of a general nature, is informational only and is only intended to familiarize students with common fire and emergency medicine activity.

I further understand that the BFR Citizens' Academy is intended to be for my benefit and education in order to better understand fire operations and procedures and is undertaken by the City of Boulder Fire Department without cost to me and therefore I expressly assume any and all risks of participation in the BFR Citizens' Academy, arising out of or in any way related to same as identified herein or otherwise and accept those risks whether or not caused by any act, omission, negligence or fault of the City of Boulder, the Boulder Fire Department or its officers and employees.
5. By signing this Agreement to Participate, including signing the acknowledgement below indicating my desire to participate in the BFR Citizens' Academy, I voluntarily release the City of Boulder from any and all claims, demands, and actions for any injury, loss or damage arising out of, or in any way related to, my participation in either the Citizens' Academy and/or the BFR Citizens' Academy, whether or not caused by the act, omission, negligence or other fault of the City of Boulder, the Boulder Fire Department or its officers and employees.
6. By signature below, I further hereby to, indemnify and hold harmless the City of Boulder from and against all liability, claims and damages, including any third party claims asserted against the City of Boulder of any bodily injury, loss, or property damage which may arise out of or is in any way related to my participation in the BFR Citizens' Academy and/or the BFR Citizens' Academy whether or not caused by my actions, omissions or negligence or other fault or by the act, omission, negligence or other fault of the City of Boulder.

I understand that by signing this Agreement to Participate, the City of Boulder is relying on and does not waive by the provisions of this Agreement to Participate the monetary limitations or other rights and immunities and protections provided by the Colorado Governmental Immunity Act, C.R.S. §24-10-101, et seq., as it is from time to time amended or otherwise available to the City of Boulder.
