

## ENTERTAINMENT VENDING

**“Entertainment vending” means the sale of recorded performance of an entertainer by that entertainer while the entertainer is performing.**

**Licenses required for permit approval:**

- **City of Boulder Sales Tax License**

- **State of Colorado Sales Tax License**  
1375 Sherman Street Denver, CO 80261  
(303) 238-7378

**Only these items in a five foot by six foot area:**

- One sign advertising the sale of the recordings (sign may not exceed one foot by one foot).
- Recordings may only be stored or displayed in the case used by the entertainer to transport the instrument played, in or on other equipment intrinsic to the act, or in a single case no larger than two feet by one foot, which may be located on a stand or table with a surface no larger than four square feet.
