### **Itinerant Merchant (door-to-door) License Instructions and Application Checklist**

- 1) An Itinerant Merchant license [application](#) must be completely filled out and signed, including: i) applicant business name, ii) legal name, home address, and birth date of all owners, officers, managers and members, and iii) local address and local phone numbers. The application will be routed to Sales Tax to review business license status and for tax remittance history and Boulder Police Department to conduct background check research on all submitted persons who will go door to door.
- 2) The applicant must submit a list of all persons (legal name, home address and date of birth) and copies of valid state issued identification cards (driver's licenses preferred) for all employees and owners working in the City of Boulder.
- 3) A sales tax deposit in the amount of \$500 (cash or certified funds only) must be submitted. For questions, contact Sales Tax at 303-441-3050.
- 4) A license fee of \$52.00 and \$7.00 per person for background checks must accompany the completed application.
- 5) The applicant must provide proof of applying for/obtaining a city sales tax license.
- 6) An application must be received at least two weeks prior to beginning sales. A late fee of \$200.00 will be charged for all applications that are submitted after the deadline.
- 7) Both a Itinerant License copy (which will list approved employee's names) and their submitted picture ID must be held by each employee conducting door to door sales under the approved business' Itinerant Merchant license and both the License copy and picture ID must be available for enforcement officer's review if requested.

Late applications are not accepted. If using this form for a new license, you must complete all fields. If using as a renewal, please complete all information and note if the information has changed since last year.
