

# 2019-2020 Winter Give-Away

## Official Rules

These are the rules for the 2019-2020 Winter Give-Away (the "Give-Away"). If you have a question regarding this promotion, please contact the Boulder Parks and Recreation at (303) 413-7200.

NO PURCHASE NECESSARY. YOU MUST BE AT LEAST 18 YEARS OF AGE OR OLDER ON DATE OF ENTRY AND A LEGAL RESIDENT OF THE UNITED STATES RESIDING IN COLORADO THROUGHOUT THE GIVE-AWAY PERIOD TO BE ELIGIBLE TO WIN. WINNERS NEED NOT BE PRESENT TO WIN. VOID WHERE PROHIBITED BY LAW. PARENTS OR GUARDIANS MAY SUBMIT ARTWORK ON BEHALF OF MINORS UNDER 18.

1. **HOW TO ENTER:** No purchase is necessary. There is no entry fee, payment or proof-of-purchase necessary to participate in the Give-Away. The Give-Away entry period starts on December 6 at noon, (Colorado time) and ends at 10 p.m. on January 20, Colorado time) (the " Give-Away Period"). To enter, submit our online form at BoulderParks-Rec.org. To enter for the Holiday Lights prizes, post a photo of holiday lights in the Boulder Civic Area or Pearl Street Mall on Twitter, Instagram or Facebook in a public post, including #boulderlightuptheholidays, @boulderparksrec or post as a comment to one of Boulder Parks and Recreation's posts. You may enter as many photos as you want, but may only enter the giveaway one time. Any other attempt at entry is void. Incomplete entries, or failure to follow the instructions, procedures or these Official Rules shall render the entry invalid. Please ONLY submit original artwork or photos YOU have created. By entering an image (or images) in this contest, you acknowledge you are the sole creator and legal copyright owner of each image entered. Also, by entering your artwork or images in this contest, you are agreeing to grant the City of Boulder unrestricted rights to use, display, post, print or reproduce each entered image without limits to time, attribution, media or application. The City of Boulder may, at its sole discretion, share or use any submitted images to promote this contest, the finalists or any campaigns related to the Boulder community, trees, parks and recreation, forestry, environmental and/or eco-system health issues. If you do not own the rights to an image or do not wish to extend your use rights to the City of Boulder according to the terms of this contest, please do not post or enter any images. All entries must have been created within the past two (2) years in Boulder County.

4. **CONTEST WINNERS:** Winners will be selected from all eligible entries received. The Sponsor will determine the finalists. The decisions are final and binding. The determination will take place about 10 a.m. (Colorado time) January 21, 2020. All entries must be received by 10 p.m. (Colorado time) Monday, January 20, 2020 to be eligible. WINNERS NEED NOT BE PRESENT TO WIN.

5. **GENERAL:** This Give-Away is subject to the laws of Colorado and the United States. Prizes will be awarded and/or delivered only to addresses within Boulder County, Colorado and its immediately adjoining counties. No substitution of prizes is offered, no transfer of a prize to a third party is permitted, and non-cash prizes may not be redeemed for cash value. Prize winners will be solely responsible for all applicable federal, state and local taxes on prizes; winners may receive an IRS Form 1099 for the retail value of the prize. All other expenses on the receipt and use of the prize not specifically mentioned herein are the sole responsibility of the winner. Any prize or portion of a prize not accepted by a winner will be forfeited and may be awarded to another entrant at the Sponsor's option.

6. **CONDUCT:** By entering this Give-Away, entrants agree to be bound by these Official Rules and the decisions of the Sponsor shall be final and binding in all respects. Sponsor reserves the right at its sole discretion to disqualify any individual found to be tampering with or disrupting the entry process or the operation of the Give-Away; or to be acting in any manner deemed by Sponsor to be in violation of the Official Rules.

**8. WINNER NOTIFICATION:** Potential winners will be notified by phone or by email. Potential winners may be required to execute an Affidavit of Eligibility, a Liability Release and a Publicity Release ("Affidavit/Release") within ten (10) days of first notification to claim prize. If any of the required documents are not returned within the allotted time period, or if a winner does not respond to attempts to contact him or her, the prize may be forfeited and an alternate winner may be selected at Sponsor's sole discretion. Any prize not accepted by a winner will be forfeited. It is the responsibility of the winner to claim the prize within the specified timeframe.
