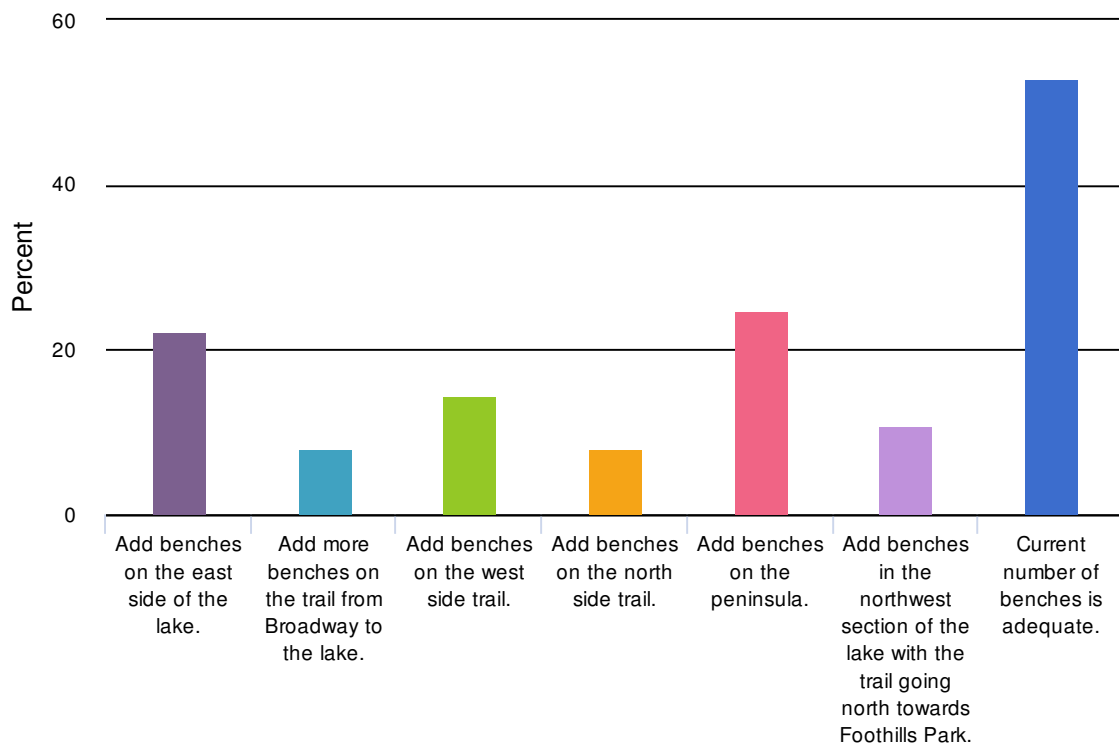

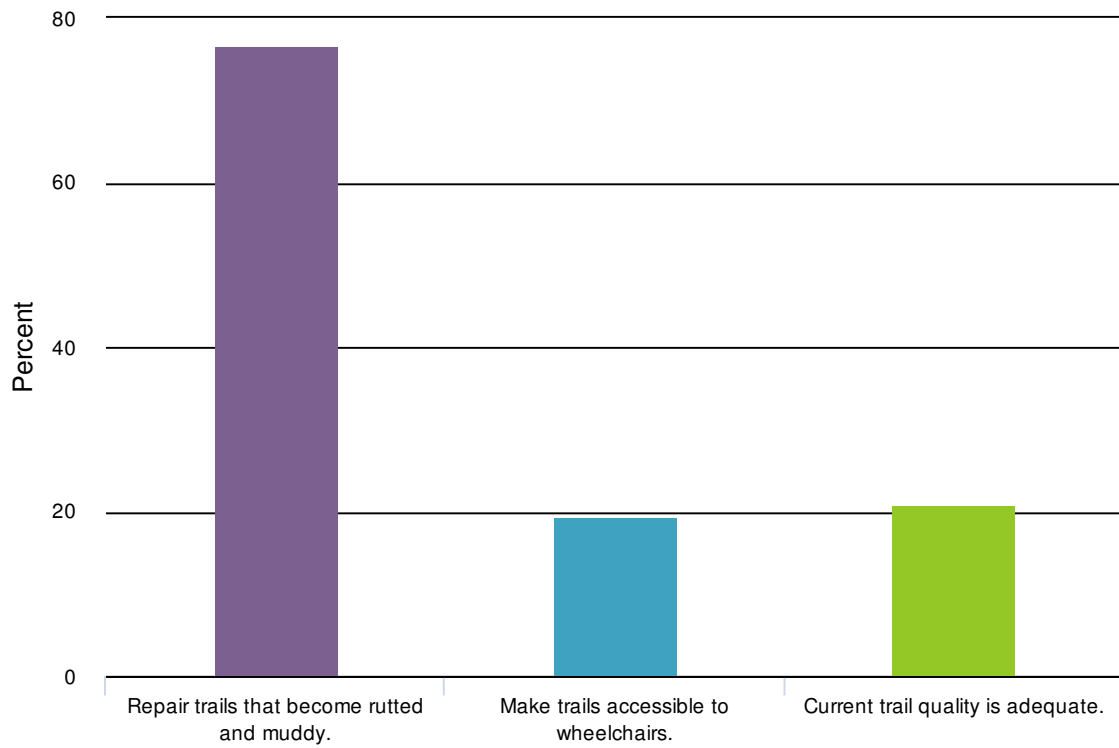

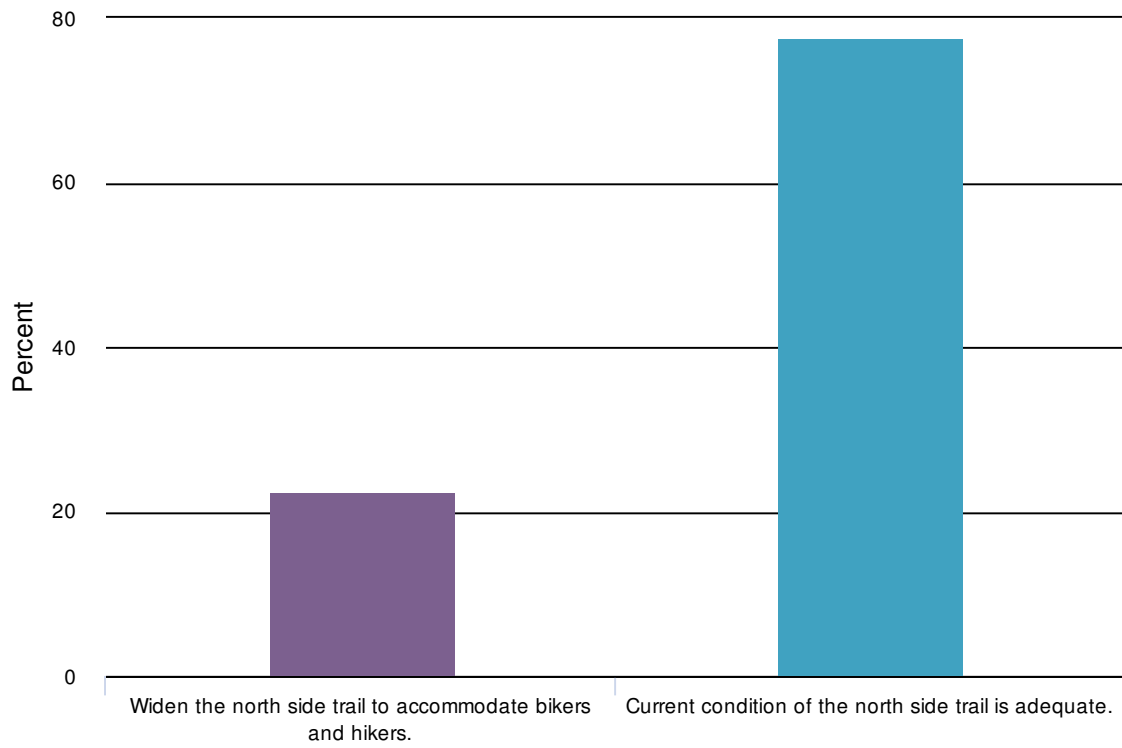

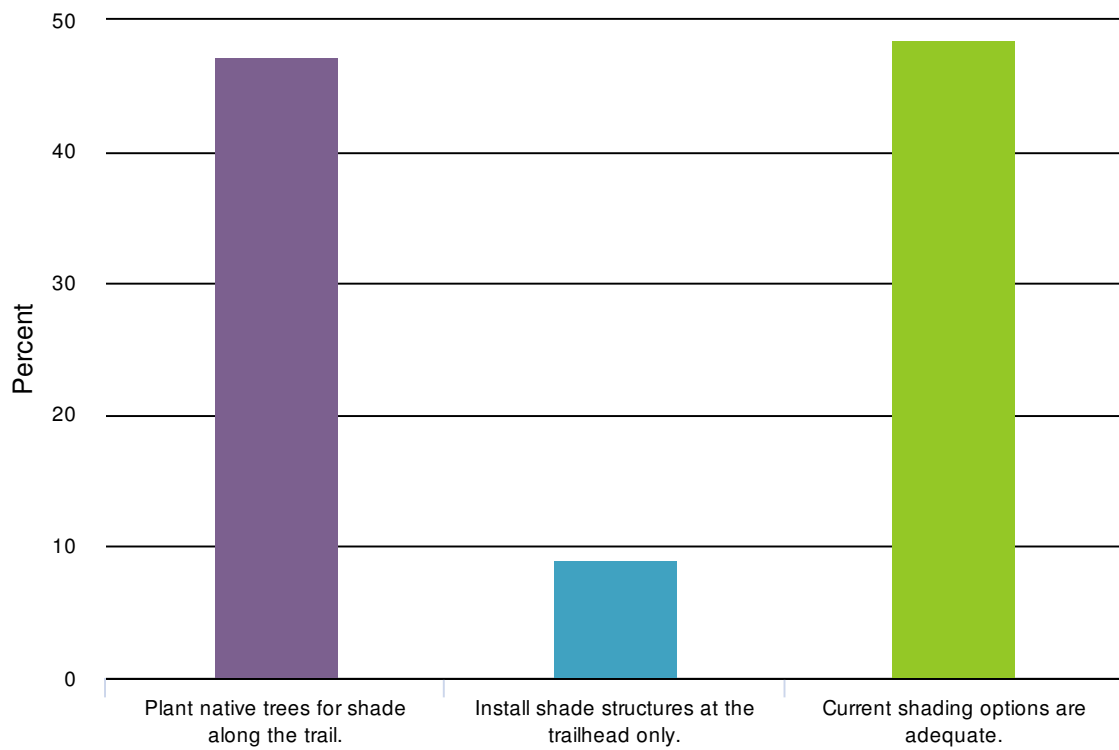

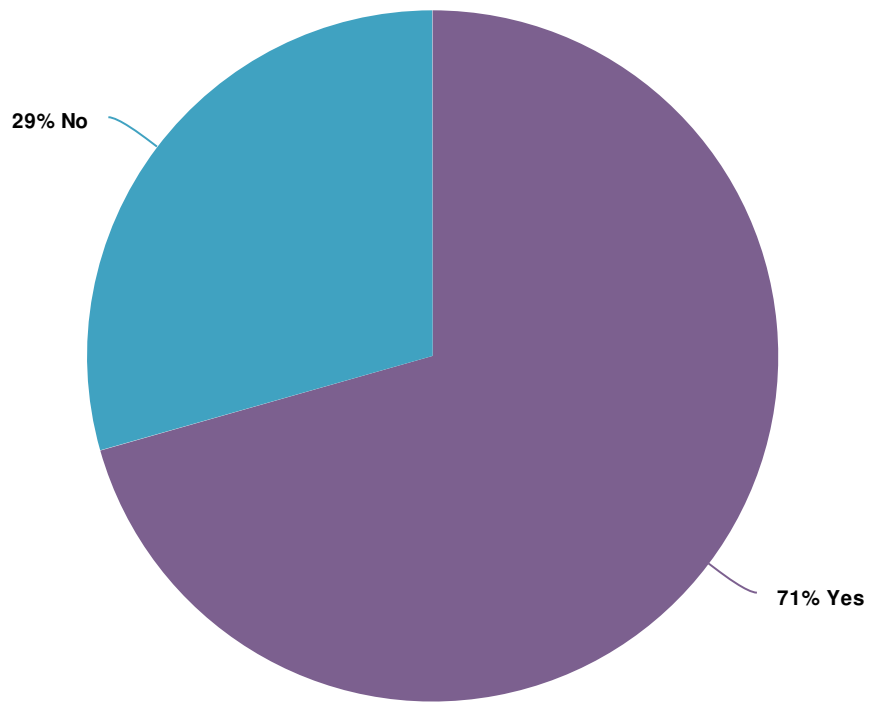

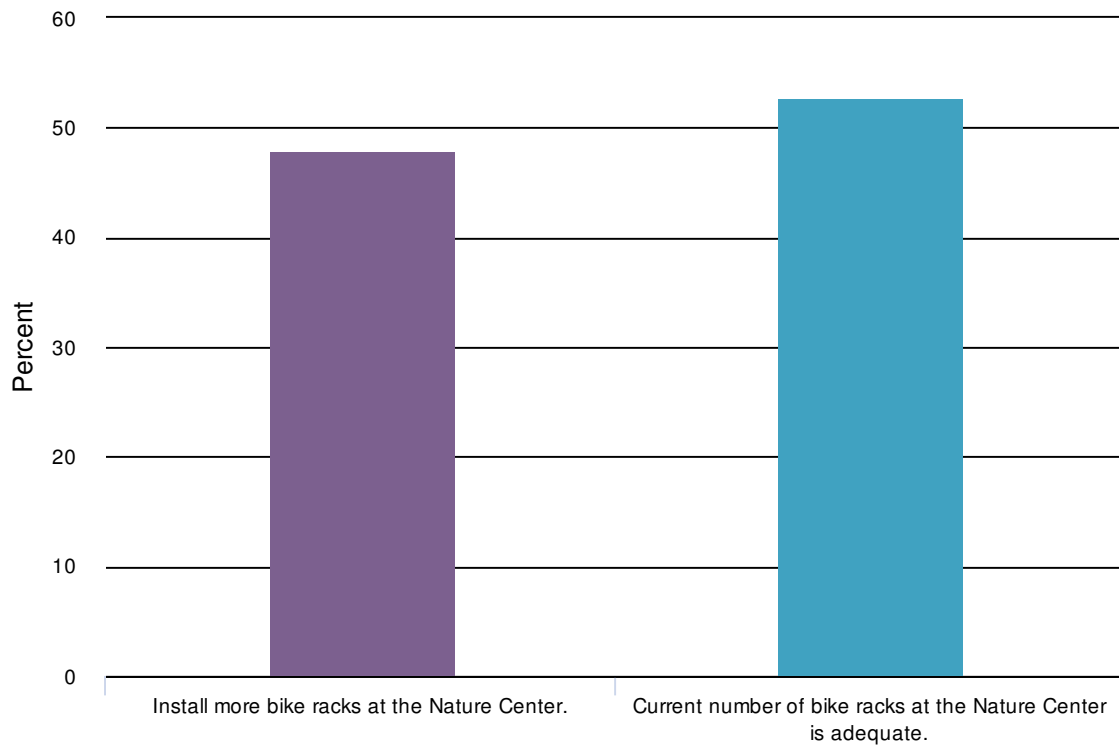

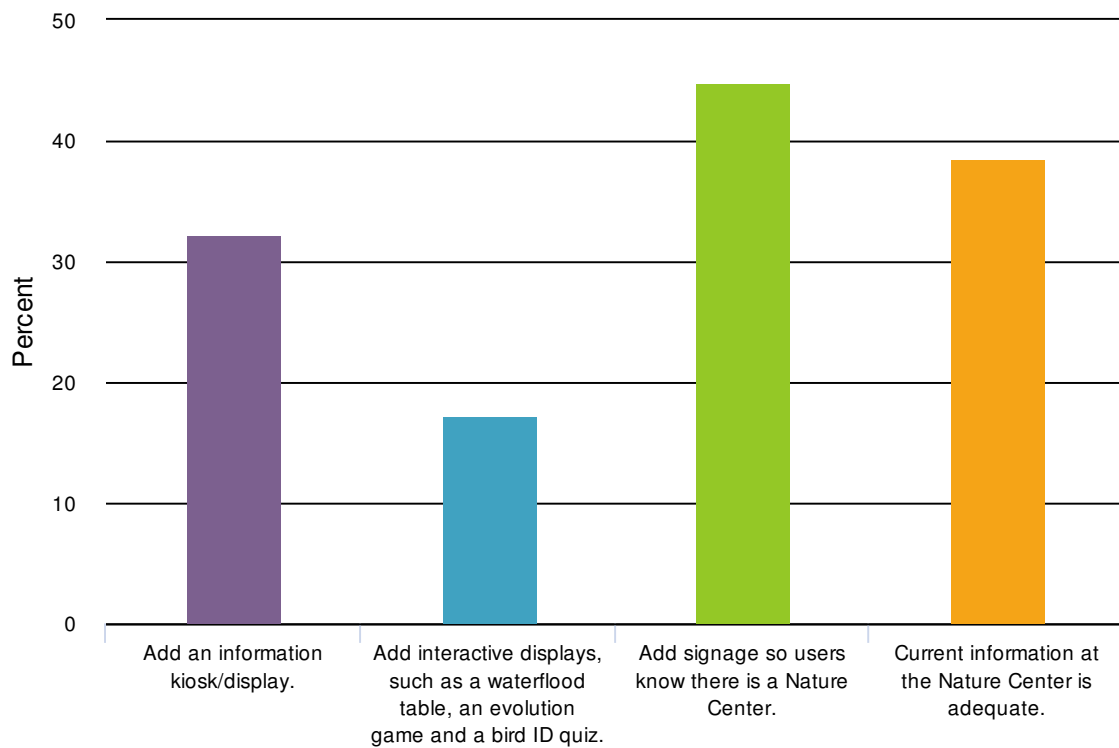

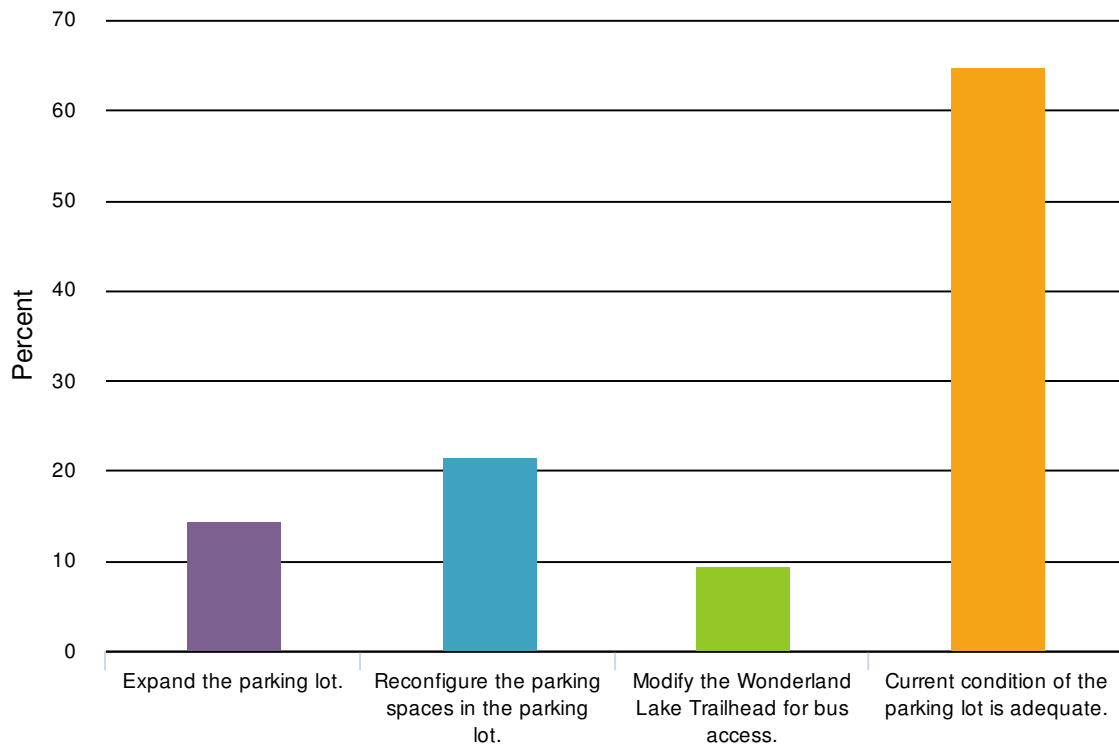

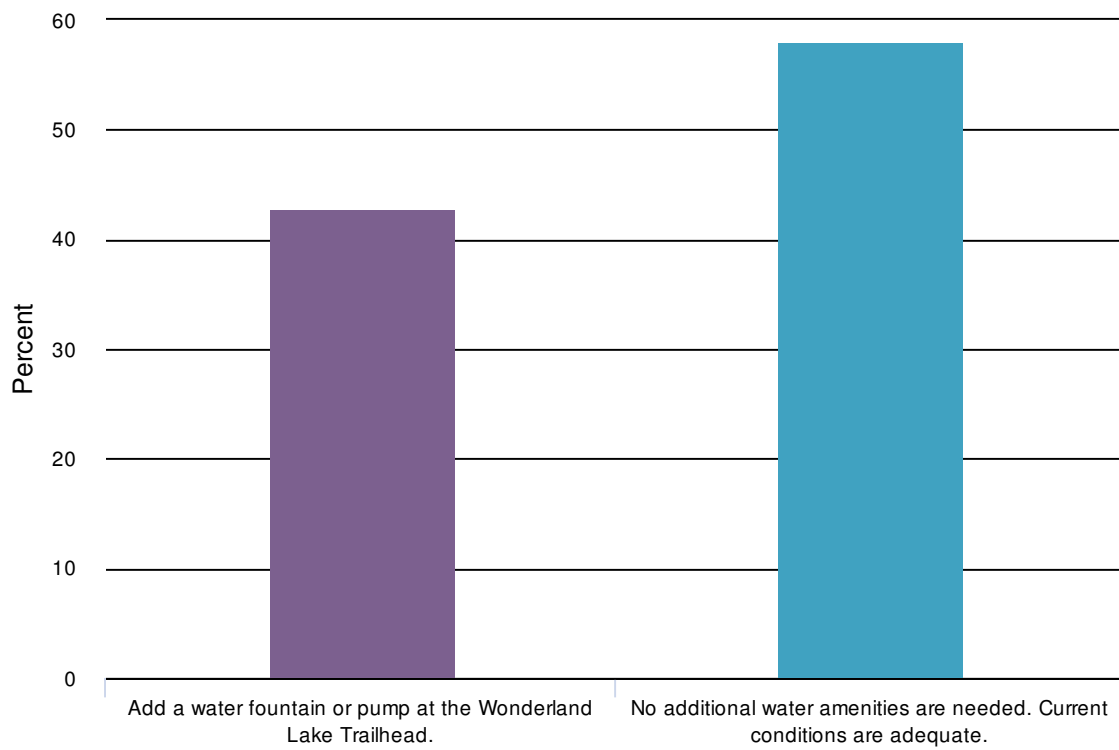

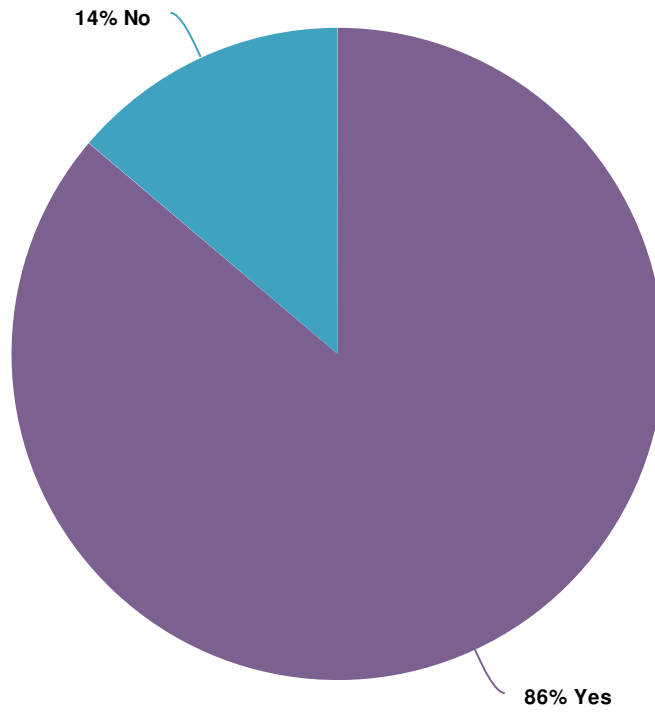

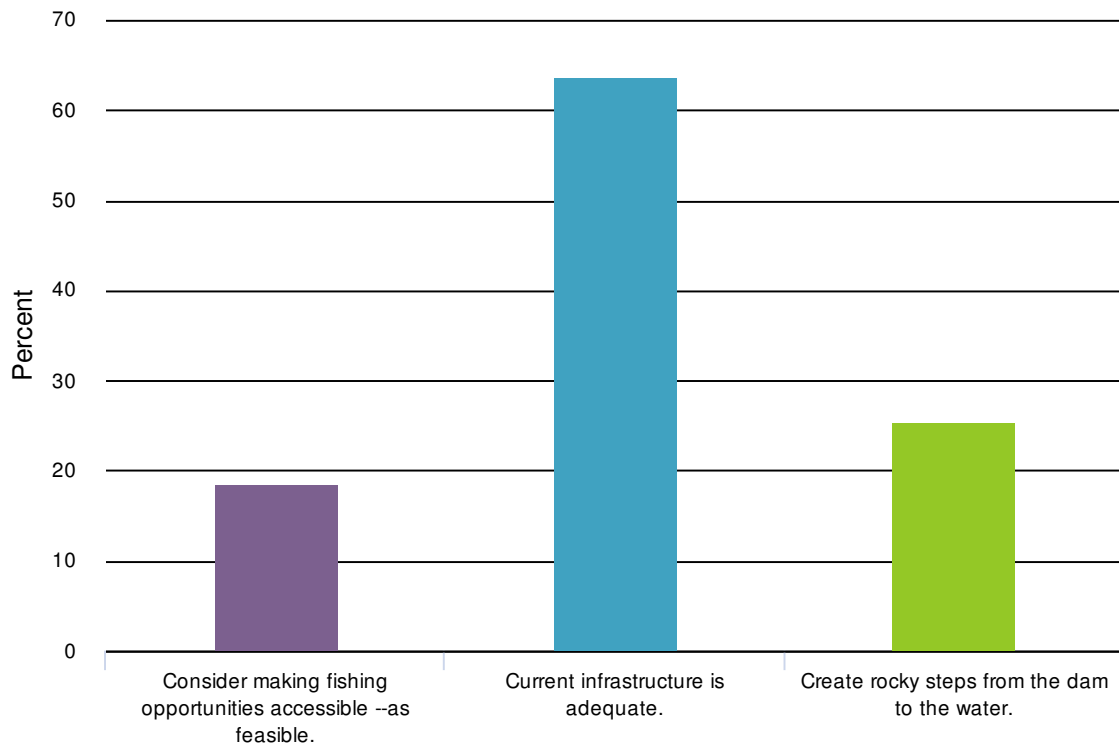

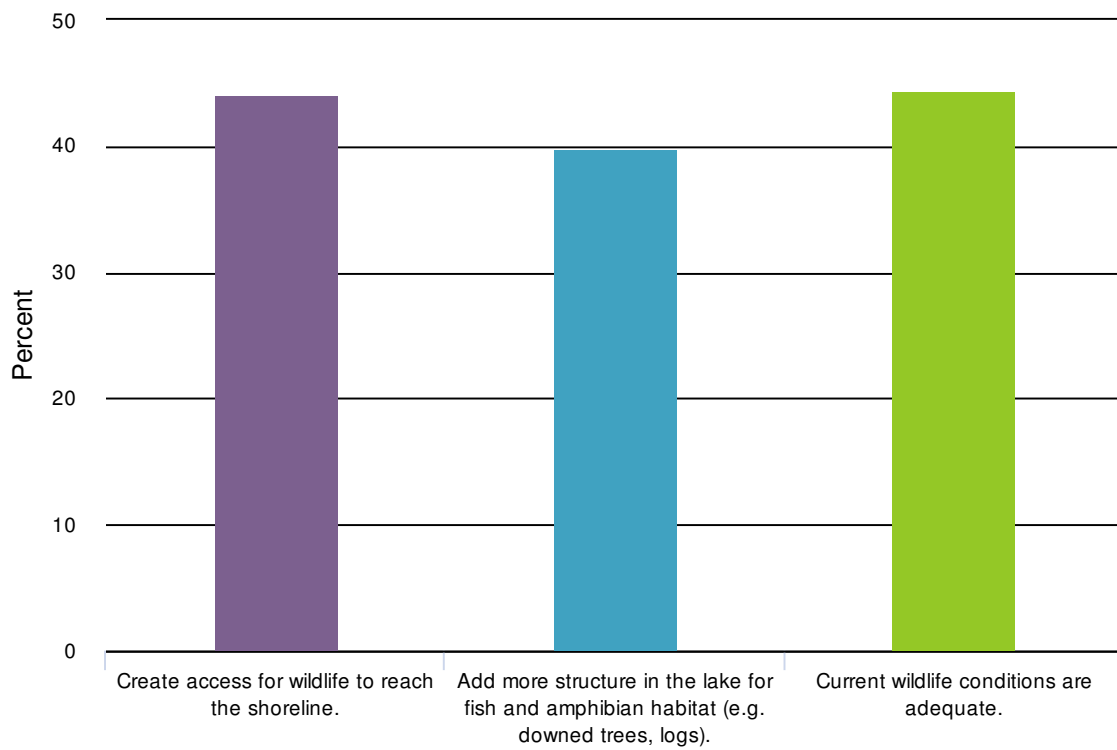

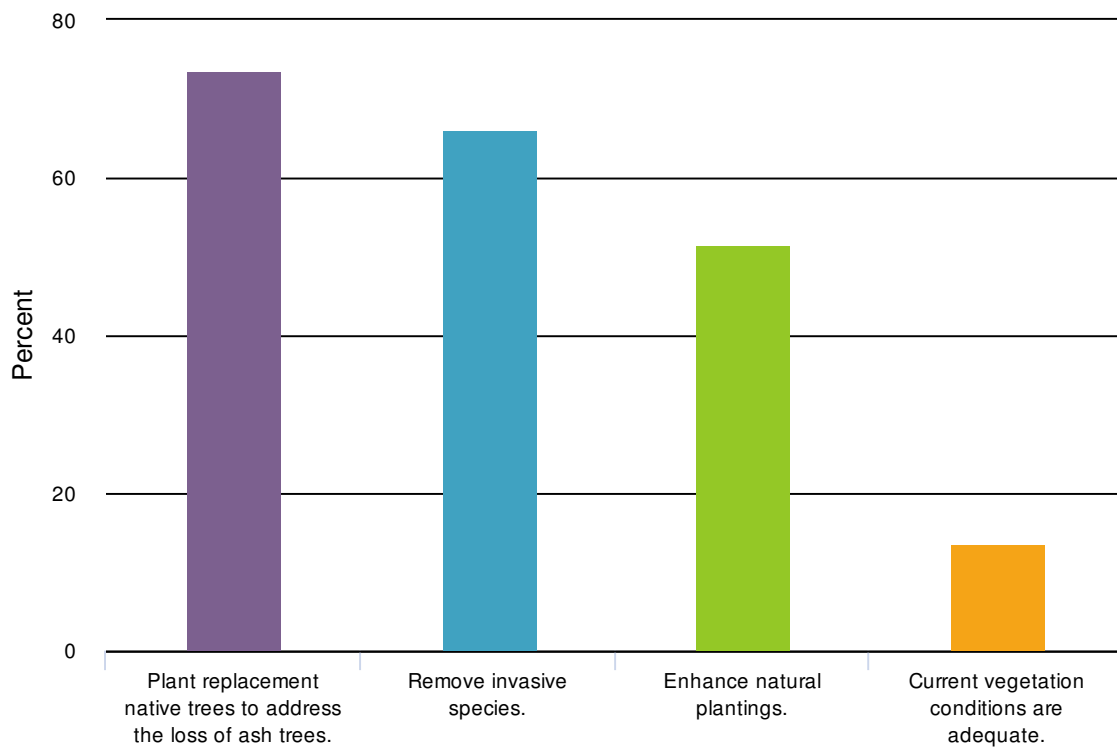

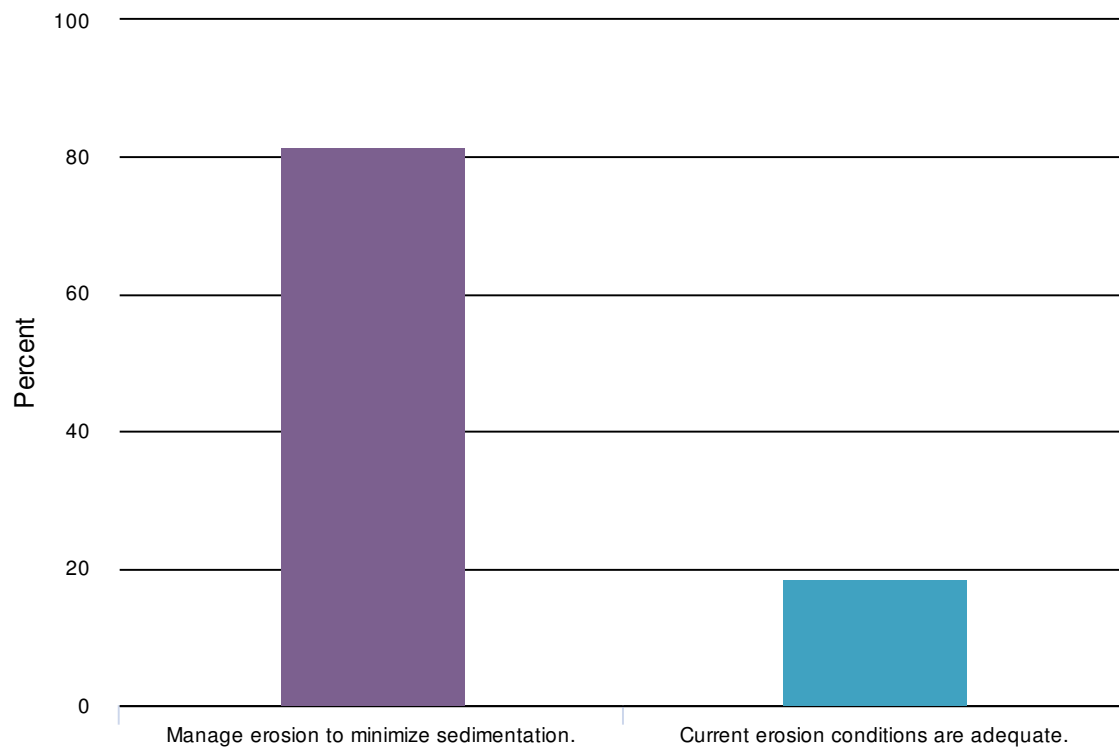

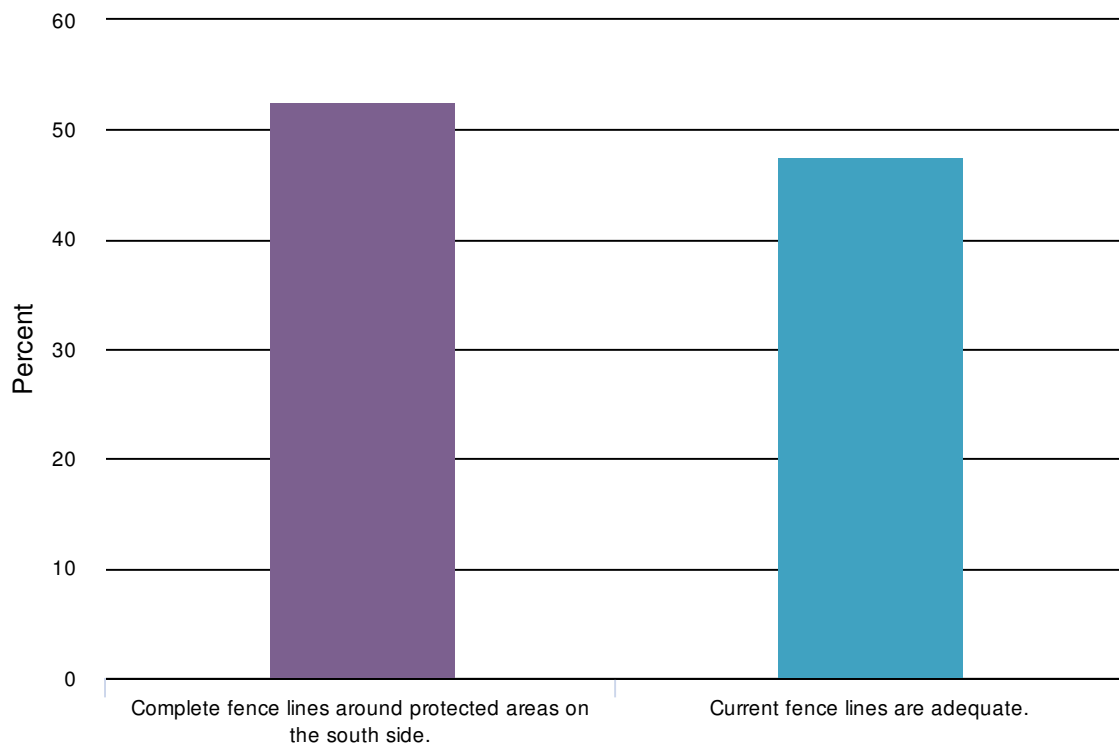

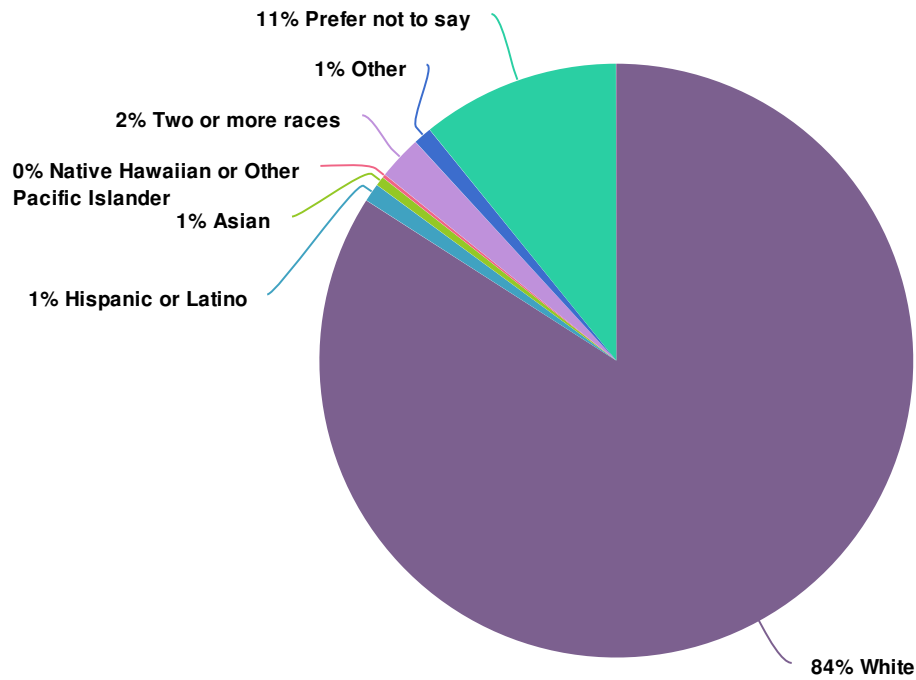
50. Which gender do you identify with?

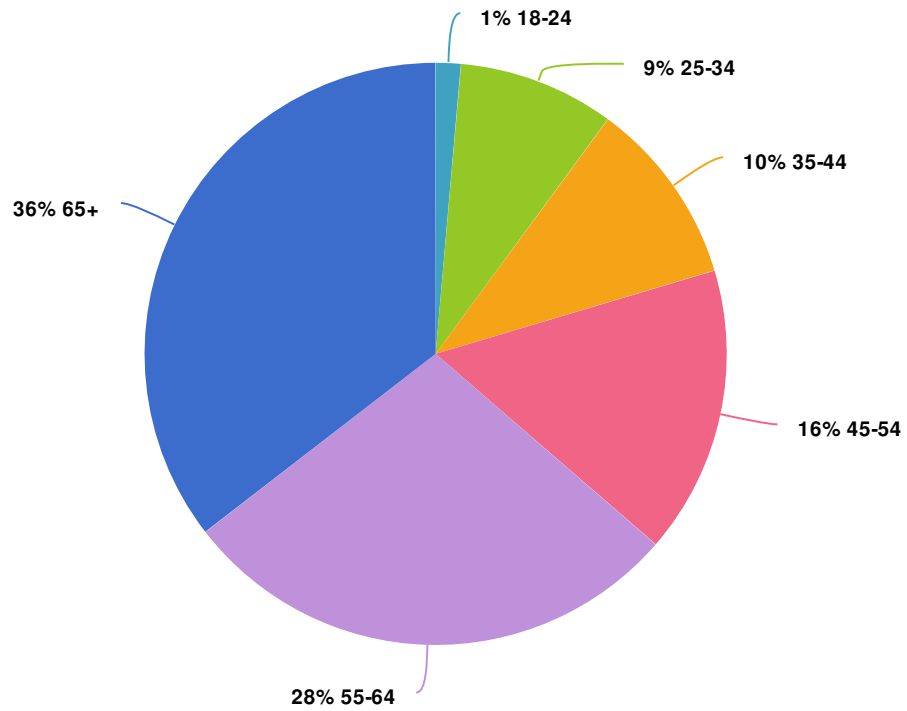
